Your dog is going to have a wonderful, home from home experience with us. He will mix with other dogs and humans in close contact all day and most of the evening, apart from when he sleeps, when he will be in his own personal suite (or communal lounge whichever he prefers) to rest.

He will be looked after as if he were our own dog, with all the love, care and attention I lavish on our own. He will have a lot of exercise and be out romping in the fields or the woods, places unfortunately, where we cannot control certain elements, such as wild animals, insects, snakes etc. Whilst we take every care with your pet, we cannot be held responsible for accidents that may happen on walks, or if he/she slips their leash and runs away. [We ask that your dog be fitted with a collar that is snug enough to fit 2 fingers inside but not too tight, and the collar must have tags with name and number on it, plus a rabies tag, in accordance with Jackson County regulations]

We like to remind clients that dogs are not robots. Moods just like with humans can change in an instant and disagreements can occur. Fights, though extremely rare, are a possible fact of life when working with more than one dog. We accept no liability for any injuries arising from fights and would ask that if you feel your dog is not adequately social to be mixing confidently and calmly with other dogs then you enquire about our one-on-one exercise service and individualized boarding arrangements and fees.

Should there be need at any time for veterinary assistance, we like for clients to use our own vet, if theirs is more than a few miles away, as ours is open every day and will often stay open a little later to accommodate my needs, or give after hours advice on the telephone.

We would ask that you, before you leave, set up with either my vet,

Or your own vet, if close enough, to have a facility that if any need for treatment should occur, the vet bills you directly or is happy to have a service on account, as we cannot afford to pay client vet fees. If the dog should fall sick, and we have not been able to contact you to get your agreement to take the dog to the vets, we are to be empowered by you to make that decision for the dog's benefit in your absence. All Vets bills are the responsibility of the client without exception.

We have your agreement that stomach upsets will be dealt with using a 24-hour fast before the veterinarian's advice is sought, unless we see symptoms that concern us.

We have your permission to bath your dog once a week or as we see fit and clip his/her nails if they will tolerate it.

We have your permission to feed the dog fresh meat, vegetables and brown rice or holistic kibble at times.

We have your permission to take your dog for a swim in the saltwater rehabilitation pool on site as and when appropriate.

We have your permission to dispense ear washes and eye washes if necessary and other treatments as deemed necessary.

We have your permission to socialize your dog with other dogs and humans in order to provide company, stimulation and training for him/her.

Lastly, we require a deposit of 50% at time of booking, the balance to be paid on the day that you pick up your pet.

Unfortunately because of the limited number of pets we facilitate here at Desperate Dogs refunds of deposit, for cancellations within two-weeks of check in date, cannot be accommodated. Accordingly, cancellations within two-days of check in date will result in full payment of booking being required.

Because of the small number of pets that we can accommodate, cancellations are very costly to our business as we cannot, at the last minute, get other bookings to replace that cancellation. Because of this even if your vacation ends sooner than you thought and you need to collect your dog earlier than booked, unfortunately the invoiced amount payable must remain as booked.

If we are picking up and delivering your pet, there will be a minimum charge of \$10, to be added to the final bill.
